Question 02

Amal and Bimal are the only shareholders and directors of A&B Ltd. Hemal who is a friend of Amal and Bimal was introduced to OM Land Developers Ltd. as a director of A&B Ltd. by Amal and Bimal. However, he was not yet appointed as a director of the company. Hemal bought an expensive land from OM Land Developers Ltd. for A&B Ltd. However, A&B Ltd. refused to pay for the land saying that they have never appointed Hemal as a director and they have never asked him to buy the land. OM Land Developers Ltd. sue A&B Ltd. to recover the money.

Explain, whether **A&B Ltd.** is liable to pay for the land purchased by **Hemal**.

Explain the responsibility of the bank, with regards to this cheque.

Question 10

(a) Amal and Amali got married in 2012 and they are separated in December 2016. They are thinking of getting a divorce. Amal promised Amali on their son's birthday to make a monthly payment of 50,000/- for her. Amali requested this to be in writing and said "if you do not pay as you promised I will take you to court". After the third month, he stopped the payment. Amali told him that she will sue him. Amal said "Good luck with that! No court will enforce an agreement between husband and wife!"

He also said "I have been paying money for you to do nothing! Guess what love and taking care of family is not a good consideration for a contract!".

Very upset from the argument she had with **Amal** she took her son for shopping. The son saw the latest "gadget man" toy through a shop window and asked **Amali** to buy it for him. **Amali** saw a label that says "half-price sale! Come grab your toy!". **Amali** picked up a "gadget man" toy and asked for the price. Shop keeper said that it is Rs.20,000/- and it could be bought for Rs.15,000/-. **Amali** was not happy with the price and she returned the toy. She tried to walk away. The shop keeper said "you cannot return it now. You have made a contract when you picked up the toy."

Discuss the legal rights of Amali regarding:

(i) Amal. (07 marks)

(ii) Shop Keeper. (06 marks)

(b) **Perera** sold a car to **Silva**. He described the car as "barely used, almost in the original condition and it is the latest model of BMW". **Silva** paid outright and took the car. After driving it for a few days the car broke down. **Silva** took the car to a garage. The repairman told him "this is a very badly used car. They have completely ruined the engine you will have to replace it. But this is such an old model I don't think they even make these engines anymore." **Silva** said "but the seller told me it was in great condition" to which the repairman laughed and said "sellers will tell anything! If you bothered to check the car before you bought it, you would have easily seen the issues. You just had to check!".

Later that day, an unknown person called **Silva** and said "I saw my car in the garage and I got your number from them. They said that you told them you are the owner of the car. You wait will you I am taking you to the police! You thief!". Surprised by this **Silva** decided to talk to the caller and realized that **Perera** had not the title to the car which he sold. The real owner was the caller who was the brother-in-law of **Perera**.
