Suggested Answers to Question Five:

(a) In a private browsing window, the browsing history and the web cache is disabled. This allows a person to browse the Web without storing local data that could be retrieved at a later date. In a regular browsing window, the users activity is tracked, although it can be removed manually by a user.

(b) This function allows to load the latest version of the web page from the webserver. Example is to see the latest score of a live scoreboard of a sports event, or live election results webpage.

(c) VPN refers to Virtual Private Network. It can be used to connect to a private network using public network connection such as the internet. It may also be used (not with certainty) to connect to sites which are blocked by internet regulators using a different route.

Some Internet Banking sites use special digital keys (which generate passwords) or mobile apps which can be logged on using fingerprints.

(e) This is a QR Code / 2D Barcode. They are used for purposes such as enabling websites to be accessed without typing (by scanning the code) using a mobile phone camera. QR codes can also be read from special barcode readers.

Suggested Answers to Question Seven:

i. Handout Master:

You can use the Handout Master tab to edit the appearance of presentation handouts, including the layout, headers and footers and background. Changes made to the handout master appear on all pages of the printed handout.

ii. Ink Annotations / Start Inking:

Ink annotations are free-hand scribbles. Ink Annotations can be done anywhere on the presentation and are not stored as a picture.

iii. Add-Ins:

An Add-In is a file (usually with an .xla or .xll extension) that PowerPoint can load when it starts up. The file contains code (VBA in the case of an .xla Add-In) that adds additional functionality to PowerPoint.

iv. Online Pictures:

This feature allows one to insert a picture directly from a website, rather than save it as a separate file in your computer and insert it.

v. Play Narrations:

This feature allows you to add either voice or music to slides and enables it automatic playing during a presentation.

vi. **Insert Icons:**

Icons are small graphics which can be inserted into PowerPoint slides. Using this feature these inbuilt icons can be used in your slides (without the need for downloading them)
