06.	Those who have sat all subjects at AA2 level except AA22 Cost Accounting and Reporting (absent or not applied) and passed AA21 - Advanced Financial Accounting. (Those who did not pass the SS2 - IT skills subject.)	They should apply and pass the 201 - Advanced Financial Accounting & Costing (AFC) subject and 202 - Information Systems in Digital Environment (ISD) subject to complete the level II (201-AFC exemption depends on sitting of AA22-CAR subject.)
07.	Those who have sat all subjects at AA2 level without SS2 - ITS and failed only AA22 - Cost Accounting and Reporting	They should apply and pass the 202 - Information Systems in Digital Environment (ISD) to complete the level II. But, they will be exempted from 201 - Advanced Financial Accounting & Costing (AFC) subject as they sat the AA22 - CAR subject.

08.	Those who passed/exempted all subjects at AA3 level.	They will be exempted from all the subjects at Level III.

Those who sat for the AA3 level examination and failed some subjects. <ul style="list-style-type: none"> • AA31 - Financial Accounting and Reporting • AA32 - Management Accounting and Finance • AA34 - Process, Controls and Audit • AA35 - Corporate and Personal Taxation 	They should sit and pass the following corresponding subjects of Level III <ul style="list-style-type: none"> • 301 - Financial Reporting (FAR) • 302 - Management Accounting & Finance (MAF) • 303 - Financial Controls & Audit (FCA) • 304 - Corporate & Personal Taxation (CPT)
10.	Those who sat AA3 and passed the AA3 level without two talent skill subjects (ECS and ITS). (ECS and ITS subjects Absent, Fail or not applied).	They are exempted from all the subjects at level III and they have to sit and pass only 310 - Business Communication subject. They should not apply 202 - Information Systems in Digital Environment (ISD) subject.
	Talent (Skill) Capstone	Talent subject (Skill Pillar)
11.	Those who passed SS1 - Effective communication skills	They will be exempted from 310 - Business Communication
12.	Those who failed SS1 - Effective communication skills	They should apply and pass 310 - Business Communication
13.	Those who passed SS2 - IT skills	They will be exempted from 202 - Information Systems in Digital Environment (ISD) at level II
14.	Those who have passed/exempted all the technical subjects with SS1 (ECS) at all the levels without (not applied / failed) SS2-IT Skills.	They will be exempted from all the levels with 202 - Information Systems in Digital Environment (ISD) subject.

N.B: To become a passed finalist, student should complete 310-Business Communication (BC) subject.
